ACQUISITION OF PRIME POWER RECIPROCATING ENGINE GENERATORS FOR THE PUERTO RICO PORTS AUTHORITY

All persons, natural or legal, who meet the minimum requirements to contract with the Government of Puerto Rico are invited to participate in the request for proposal referenced above. Such requirements are established under Article 31 of Act No. 73 - 2019, as amended, known as the "General Services Administration (GSA) Act for the Centralization of Purchases of the Government of Puerto Rico of 2019"as well as the applicable provisions of the Uniform Regulations for Purchases and Bids of goods, works, and nonprofessional services of the General Services Administration of the Government of Puerto Rico, Regulation No. 9230.

SCOPE OF WORK

This section refers to the Equipment Specifications and Services specified in RFP 23J-09392 and dictates the scope of work and requirements for PRIME POWER RECIPROCATING ENGINE GENERATOR(S), including controls, required auxiliaries, fuel conditioning equipment and accessories ("Specification" or "Specifications").

Each engine generator package and required ancillary systems shall include features needed for safe, highly reliable, efficient, long-term operation. Design shall be in accordance with good engineering practice, applicable standards, and shall meet the strict demands typical of industrial power plants for safety and reliability, as well as those imposed by the Owner and all regulatory agencies having jurisdiction in the Commonwealth of Puerto Rico.

REQUEST FOR PROPOSAL (RFP) DOCUMENT

The Request for Proposal documents must be downloaded from ASG's website (www.asg.pr.gov). Documents will be available from Friday, February 17, 2023, for an indefinite period of time. Any bidder or person interested in participating in the bid may obtain the related specifications for free, by accessing the ASG website, Procurement Reform, where they will find the link corresponding to the reference bid.

REOUESTS FOR CLARIFICATION AND OUESTIONS

Request for Clarifications and Questions relating to this RFP must be submitted via email **no later than Friday**, **March 3, 2023**, **at 4:00 p.m.** Submitted questions should reference to the RFP number and provide the point of contact for the prospective Bidder. ASG shall offer the corresponding answer within a term of three (3) days. Also, ASG will compile all questions and issue answers to all questions to prospective Bidders on its website.

From the time the RFP is issued until the time an award is made, vendors may not in any way contact ASG directly. Questions regarding the RFP may only be asked during the pre-proposal conference and through e-mail. Questions asked through e- mail will only be answered if they are sent to the e-mail address provided for asking questions and will only be answered if sent in during the time allowed for asking clarifying questions.

Vendors must not contact ASG in any other way.



BID BOND

Each bidder shall include a bond ("Bid Bond") equal to five percent (5%) of the bid price in the offer in the submission of the proposal. Failure to comply with this requirement will lead to the rejection of the offer or the cancellation of the award.

SUBMISSION DUE DATE

Proposals are to be must be received **no later than Thursday, March 23, 2023, before 9:00 am**, and must be submitted via e-mail to <u>ofertas@asg.pr.gov</u> and in-person to the Office of the Bid Board at the Minillas Government Center, North Tower, 12th Floor, San Juan, Puerto Rico. Responses to the RFP received after the prescribed deadline will not be accepted. The Proposer shall submit the response via e-mail to the Bid Board Secretary. The e-mail subject line must contain the following: "Attention: Proposal RFP 23J-09392 from <Contractor name>".

OPENING OF PROPOSALS

Proposals will be opened on Thursday, March 23, 2023, 9:30 am Atlantic Standard Time at ASG offices.

REGISTERED AND UNREGISTERED PROPOSERS

Proposers should follow instructions in this RFP describing RUL registration timing and requirements.

WARNINGS

- 1. ASG may order the partial or total cancellation of the RFP, even after having performed the opening, if a contract has not been formalized or a purchase order issued, if the cancellation of the RFP results in the best interest of the Government of Puerto Rico.
- 2. ASG may amend any invitation and/ or tender of the RFP, when it serves the best interests of the Government of Puerto

Rico.

3. The ASG Administration and Bid Board will faithfully comply with the public policy of preferential purchases provided by Law.
