Se notifica a los proponentes interesados a participar en la Solicitud de Propuesta Sellada de referencia, las siguientes preguntas y contestaciones:

Proponente: AMERICAN PROFESSIONAL STAFFING SOLUTIONS, LLC (APS SOLUTIONS)

1. Will the pre-proposal meeting be conducted in Spanish or English?

Answer: The pre-proposal meeting was conducted in Spanish.

2. Can you provide more detail on the types of Temporary Employment Personnel that will support this contract?

Answer: The Government is looking to establish a Catalog Contract for Temporary Employment Services for all Government Entities that could require temporary staffing solutions. This could range from office positions to field positions or even medical staff. Your company does not have to bid for every type of position; however, the Proponent should demonstrate that it has experience providing temporary staffing employees in areas that could be required by the Government. Also, the proposal document should list all the job categories that could be offered by your company.

3. Can you provide more details as to the Government entities that will utilize this contract?

Answer: Please, refer to Law 73-2019 and Regulation No. 9230 as amended, known as the "2019 General Services Administration Act for the Centralization of Purchases of the Government of Puerto Rico". This Agency is the governmental entity responsible for implementing the public



policy regarding the acquisition of nonprofessional goods and services for the Government of Puerto Rico (Government or GPR). ASG has the authority to act as the contracting and negotiating entity for all government entities. This includes the authority to procure goods and services on behalf of all governmental entities.

Regulation No. 9230 establishes the guidelines for the Government's acquisition processes. For example, AEE is an exempt entity that could conduct its own procurement processes, except for those instances where a Centralized Contract is in place where they will be required to establish purchase orders against it. The purpose of this RFP process is to establish a centralized contract with pre-qualified contractors to provide Temporary Staffing Services.

4. Can you provide a copy of the solicitation documents in English?

Answer: No, all the documents are in Spanish.

5. Does the proposal response need to be submitted in Spanish or can the proposal be submitted in English?

Answer: The proposal response can be submitted in Spanish or English.

6. Can you provide the Annexes in Word version or another editable format?

Answer: Annexes can be printed, completed, signed, and attached to the proposal document.

7. On the pricing spreadsheet tab "Desglose del Markup", what is the intent of % de Preferencia"? Is this percentage an addition of deduction from the Regular Time Markup and Overtime Markup?

Answer: The Pricing worksheet was amended to eliminate the field that asked for the % of Preference or "% de Preferencia". Please use this new version to submit your proposal. All other terms and conditions remain the same. See Amendment No 2.
