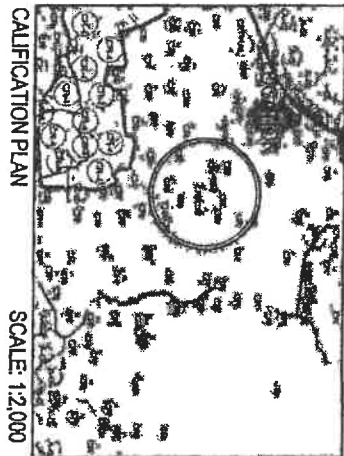
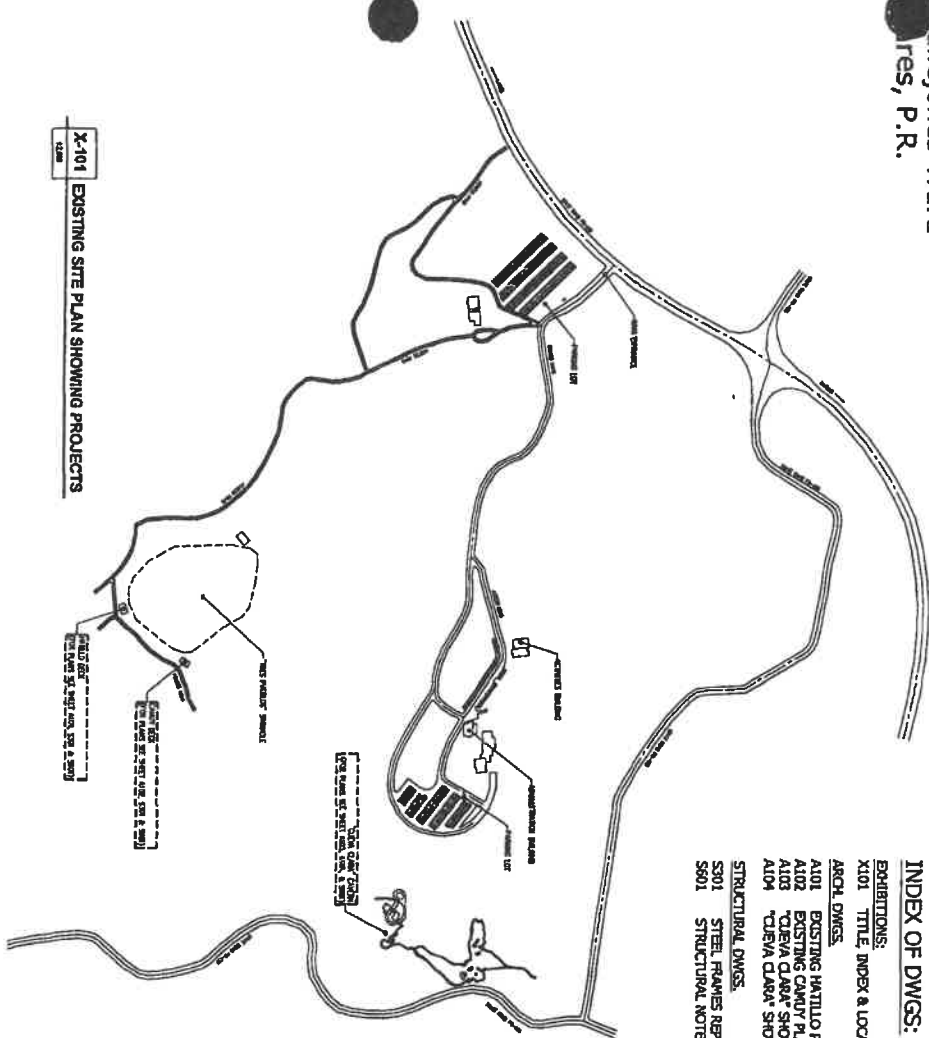

X-101 EXISTING SITE PLAN SHOWING PROJECTS

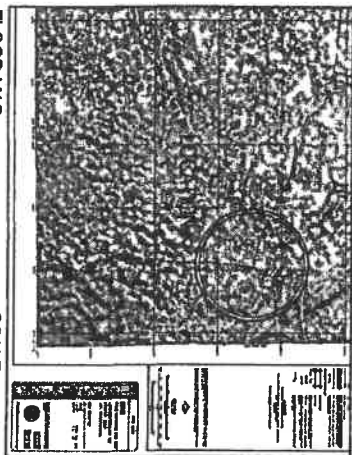

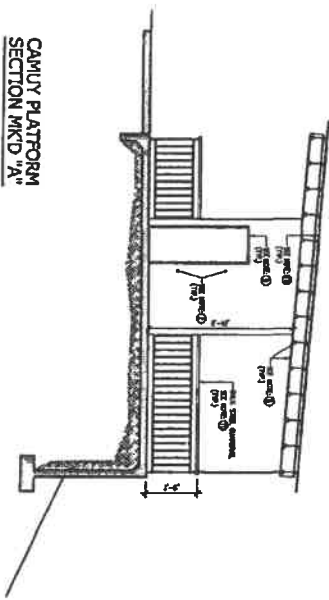

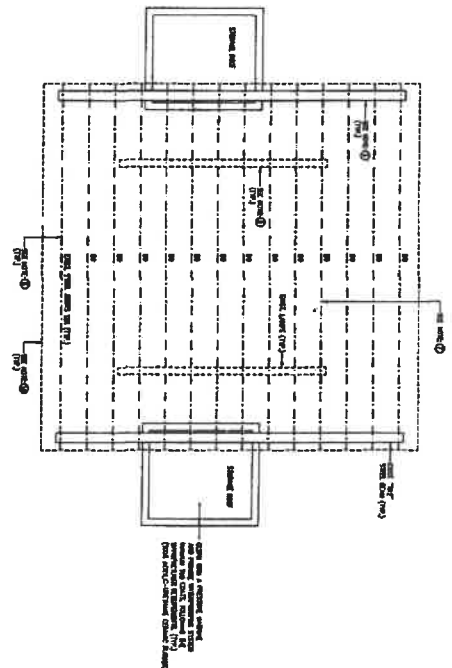

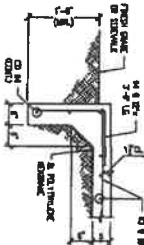
